ANNUAL MAINTENANCE AGREEMENT

SERVICE PLAN #1 \$240.00

Clean boiler flues and smoke pipe to base of chimney. Clean fuel pump strainer and replace fuel oil filter. Regulate pump pressure. Oil all motors. Clean nozzle assemble and replace nozzle. Test electrical equipment. Adjust oil burner operation for maximum efficiency. Note: Each additional unit plan #1 Add \$210.00

SERVICE PLAN #2 \$ 335.00

Service unit the same as plan #1. Plan #2 includes the replacement of the parts that guarantee the firing of the oil burner, with an allowance, and up to 3 one hour service calls during regular business hours. Note: Each additional unit plan #2 Add \$290.00, including oil fired hot water heaters.

TERMS OF SERVICE PLAN #2

1. Crest Fuel Oil Co., Inc reserves the right to decline acceptance of Service Plan #2 after inspection of heating equipment. If unit is not accepted customer will be billed for Service Plan #1.
2. This agreement is only valid if the customer purchases their entire fuel oil requirement from Crest Fuel Oil Company, Inc.
3. This agreement does not cover service calls for the following; oil burner switches off, thermostat below room temperature, fuses or circuit breakers off, power failure, gelling of fuel oil in tank, water in fuel oil, low water in steam boiler, low water pressure in hot water boiler, unit running on arrival, inadequate fuel oil supply when customer is on "will call" or "C.O.D." basis.
4. All parts described in Service Plan #2 will be replaced at no charge or with a \$125.00 allowance when they become defective through normal use. Parts damaged by flooding, lightning, or other acts not considered normal use will be billed at the current retail cost. Obsolete parts not covered.
5. This agreement is void if heating equipment is serviced by others.
6. This agreement does not cover the material cost for items described above as "parts not covered".
7. This agreement does not cover the labor cost for items described above as "parts not covered".
8. This agreement covers the labor cost for items described above as "parts covered" as follows; During regular business hours from 8:00 AM – 4:30 PM Monday – Friday. Any service provided outside of regular business hours or on a Weekend or Holidays will be billed at ½ our normal overtime rate.
9. No refund will be issued on any Service Plan after the work is completed. This agreement is transferable in the event of a home sale
10. Any Service Plan completed on a Saturday will be charged an additional \$50.00
